

Measuring Our Impact



COVID-19 Response



In 2020, South Florida Community Development Coalition actively worked to meet the need for capacity building and direct technical assistance in response to COVID-19 to ensure both the short-term and long-term needs of South Florida's nearly 7 million residents were being addressed. SFCDC was able to work across sectors connecting resources and understanding the best practices instrumental to community development efforts in Miami-Dade County, Broward County, and Palm Beach County while facilitating the collaborative efforts and the framework necessary for more coordinated and impactful community development.

Florida remains one of the areas greatest impacted by COVID-19, sea level rise, and affordable housing. With most of the economic landscape comprised of small businesses, micro-businesses, the service industry, and tourism, South Florida continues to be greatly impacted. This combination of factors has led to rent insecurity, mortgage insecurity, food insecurity, and a high demand for resource support. Guidance on best practices was needed for policy makers and resource holders from trusted groups, like SFCDC, fielding community concerns to ensure funds and resources were being dispersed in an equitable manner.

In addition to capacity building, technical assistance, and resource dissemination SFCDC also supported Axis Helps and provided technical supplies to small business as a response to COVID-19.

COVID-19 Small Business Support

South Florida Community Development Coalition is dedicated to supporting small businesses and the community based organizations that serve them. In addition to capacity building and resource support, SFCDC made a technological donation to small businesses in the Allapattah small business corridor. This donation will allow five small business to create electronic systems to:

Resilience



Keep Safe Miami

Keep Safe Miami equips affordable housing owners and operators with tools to assess their buildings' resilience to climate change and natural disasters, and provide them with actionable strategies and guidance on financing to address these vulnerabilities.

Keep Safe Miami includes four components:

For Developers:

• Portfolio Risk Analysis Tool - identify at a high-level the most and least resilient properties in a portfolio.

• Property Resilience Audit Tool - evaluate specific needs of properties and identify resilience strategies at the building level through site assessments.

• Funding Resources Guide - provide information to affordable owners and portfolio managers about available resources as they work to secure capital to implement relevant resilience strategies.

For Residents:

• Training – Residents will soon be able to sign up to receive free training on disaster preparedness, as well as actions they can take to increase their energy efficiency and save on costs.

South Florida Community Development Coalition is proud to be a partner on Keep Safe Miami.

Miami Affordability Project (MAP)

The MAP serves as a tool for planners, policymakers, affordable housing developers, community organizations, and urban researchers to explore Miami's housing landscape, address needs, and promote informed decisions about housing policy.
